The Town of Bloomsburg received its letter dated February 17, 2022, regarding HUD’s review of its Program Year 2020 CAPER. At the conclusion of this letter, it was requested that the Town of Bloomsburg notify your office within 35 days regarding any comments.

Please accept this letter as formal notification that the Town of Bloomsburg has received and reviewed this letter. Please accept the following comment concerning the CAPER review:

The CAPER Review cites that the Town’s timeliness ratio was calculated at 1.78 times its annual grant on August 2, 2021. This is incorrect. The Town’s Program Year 2020 timeliness ratio was 1.25 according to the PR56 report. The 1.78 was for Program Year 2019. Therefore, the town was in compliance with the 1.5 timeliness standard for Program Year 2020.


