Call to Order

After it was determined that a quorum was present, Mr. Herman called the meeting to order at 10:07 a.m.

Public Forum

No comments were received from the general public.

Approval of the April 8, 2022, Meeting Minutes of the SEDA-COG MPO

Mr. Kaufman made a motion to approve the minutes from the April 8, 2022, MPO meeting; Ms. de Silva seconded the motion; motion carried.

TIP Administrative Modifications and Amendments

Mr. Herman stated there is an amendment from PennDOT District 2-0 adding a safety project using HSIP funding on US 22 in Mifflin County. Mr. Schultz stated this is a new project to install solar powered sequential lighted chevrons on US 22 in Derry Township, Mifflin County. Mr. Schultz stated this project is a new initiative and will be installed in curve areas. This project is being combined with two projects in Centre County and PennDOT is hoping for a quick turnaround of the project and to be able to secure a much better bid by joining this with other similar solar powered sequential lighted chevrons in the District.

Mr. Colussy made a motion for the MPO to approve the amendment for PennDOT District 2-0 for the lighted solar powered sequential chevrons; Mr. Mullins seconded the motion; motion carried.

Mr. Schultz summarized the TIP administrative actions for PennDOT District 2-0.

Ms. de Silva made a motion for the MPO to approve the TIP administrative actions as presented for PennDOT District 2-0; Mr. Colussy seconded the motion; motion carried.

Mr. Ranck summarized the TIP administrative actions for PennDOT District 3-0.

CSVT Northern Section Opening/Southern Section Groundbreaking

- A public walking/biking event will be held on Saturday, 6/25, from 10 a.m. to 3 p.m. Attendees will park at the Ridge Road interchange.
- An invitation-only ribbon cutting/groundbreaking ceremony (for public officials, parties who worked on the project and the media) will be held on Wednesday, 6/29, at 10:30 a.m.
- Open to traffic is anticipated by mid-July.

Southern Section

- The 1st earthwork contract was awarded to Trumbull Corporation from Pittsburgh in early May and notice to proceed was issued on 5/16/22.
- Final design work continues for the 2nd (structures) and 3rd (paving) contracts
 - PennDOT has mostly focused on preparing plans for the 9 new bridges that will be included in the 2nd contract.
 - FHWA is currently reviewing the final design noise analysis and PennDOT anticipates receiving FHWA's approval to move forward with public coordination this summer related to the proposed noise barriers that will also be included in the 2nd contract.

SEDA-COG MPO Self-Certification Resolution

Mr. Herman reviewed the Resolution for the SEDA-COG MPO Self-Certification of the Metropolitan Transportation Planning and Programming Process. This resolution certifies that the SEDA-COG MPO's transportation planning process is being carried out in accordance with all applicable federal requirements and that the local process to enhance the participation of the general public, including the transportation disadvantaged, has been followed in developing the Transportation Improvement Program (TIP) and the Long-Range Transportation Plan (LRTP).

Mr. Colussy made a motion for the MPO to approve the SEDA-COG MPO Self-Certification Resolution; Mr. Kaufman seconded the motion; motion carried.

2023-2026 Transportation Improvement Program (TIP) Adoption

Mr. Herman reviewed the following handouts provided in the meeting packet:

Mr. Kaufman made a motion for the MPO to adopt the 2023-2026 Transportation Improvement Program (TIP) and approve submission of all the TIP documents to PennDOT; Ms. de Silva seconded the motion; motion carried.

Mr. Herman stated that the new TIP will take effect October 1, 2022.

SEDA-COG MPO Title VI Program Adoption

Mr. Herman briefly referenced recent activity with preparing the SEDA-COG MPO Title VI Program. He stated that the SEDA-COG MPO Title VI Program certifies the MPO's compliance with federal requirements under Title VI of the Civil Rights Act and referenced a resolution in the meeting packet for adopting the Title VI Program.

Ms. Brummer provided a PowerPoint presentation on the Title VI Program Update.

Ms. de Silva made a motion for the MPO to approve the SEDA-COG MPO 2022 Title VI Program; Mr. Kaufman seconded the motion; motion carried.

SEDA-COG MPO Bylaws Amendments

Mr. Herman reviewed the SEDA-COG MPO Bylaws amendments provided in the meeting packet and discussed the primary adjustments made to the original 2012 bylaws. The MPO bylaws will also be taken to the SEDA-COG Board of Directors for its endorsement on June 22, 2022.

Mr. Mullins made a motion for the MPO to approve the revised June 10, 2022 SEDA-COG MPO Bylaws; Mr. Colussy seconded the motion; motion carried.

Active Transportation Committee Update

Ms. Wilde provided the following update for the Active Transportation Committee:

- Six trail counters are going to be purchased and the committee will be working with Michelle Beiler from Bucknell University on gathering trail usage data for the region.

- The Northumberland County Rail Trail Master Plan is in the process of being approved by DCNR.
