### **Call to Order**

After it was determined a quorum was present, Mr. Herman called the meeting to order at 9:35 a.m.

### **Public Forum**

There were no public comments presented.

### **Approval of Jan. 30, 2026, Meeting Minutes of the SEDA-COG MPO**

*Mr. Kerstetter made a motion to approve the minutes of the Jan. 30, 2026 MPO meeting; Mr. McLaughlin seconded the motion; motion carried.*

### **TIP Administrative Modifications and Amendments**

Mr. Schultz summarized the TIP administrative modifications for PennDOT District 2-0 as information-only items that do not require MPO approval.

Mr. Schultz summarized the TIP amendments for PennDOT District 2-0 included on pages 9 and 10 of the packet.

*Mr. Lettiere made a motion to approve the TIP amendments as presented by PennDOT District 2-0; Mr. Molter seconded the motion; motion carried.*

Mr. King summarized the TIP amendments for PennDOT District 3-0 included on pages 19 and 20 of the packet.

*Mr. Molter made a motion to approve the TIP amendments as presented by PennDOT District 3-0; Mr. Skavery seconded the motion; motion carried.*

Mr. King summarized the TIP administrative modifications for PennDOT District 3-0 items as information-only items that do not require MPO approval.

### **CSVT Project Status Report**

Mr. King provided a status report on the CSVT project.

**Southern Section Structures Contract:** The project is roughly 99% complete overall. The nine new bridges and four noise walls are nearing completion, with only minor cleanup items left. All work is set to be finished in May 2026.

**Southern Section Paving Contract:** Work on the paving project has begun. The contractor has begun clearing and grubbing, installing drainage, and doing excavation and grading. UGI has begun utility relocations along North Old Trail; PPL has begun utility relocations along South Old Trail. The mainline CSVT Southern Section highway is anticipated to be opened to traffic in Fall 2027. The RT 61 Connector is anticipated to be fully completed and opened to traffic in Fall 2028.

**Southern Section Interchange with Routes 11/15 and Route 522:** To improve access for northbound (NB) traffic on the Selinsgrove Bypass (Routes 11/15) destined for Selinsgrove or other points to the south via Route 522, a new ramp stub and traffic signal to allow traffic to turn left

from the NB off-ramp to head directly south on Route 522 will be installed. It is anticipated to be fully in place and functional when the CSVT mainline is opened to traffic in late 2027.

**Southern Section Intelligent Transportation Systems (ITS) Devices:** The CSVT project team is developing plans to incorporate variable message boards and traffic cameras into the Southern Section design. Bids are anticipated to be opened in summer 2026 for a separate smaller construction contract to install permanent message boards on each direction of the CSVT mainline and traffic cameras at each of CSVT's interchanges.

Mr. King provided an overview of the Ridge Road project in Point Township, which is funded through CSVT allocations. The estimated \$20 million project will include roadway improvements and a bridge replacement. Information can be found on PennDOT's website and public outreach will be advertised for this project.

### **Unified Planning Work Program (UPWP) Staff Activity Report**

Mr. Herman highlighted items from the SEDA-COG MPO Staff Activity Report – April 2026 provided in the meeting packet.

Mr. Kiel provided an update on the Local Technical Assistance Program (LTAP) activities. He said SEDA-COG has hosted and will continue to host multiple training classes this spring. Among the most notable is the Leadership Development for Public Works class. In addition, LTAP-related training opportunities include a Chainsaw Safety class scheduled for Jun. 9 and an Equipment Operator Training class scheduled for Jul. 24.

Mr. Herman highlighted the components of the MPO Strategic Plan's Annual Implementation Progress Report provided in the meeting packet.

### **ARC Local Access Road Program Funding**

Betsy Lockwood, SEDA-COG Director of Project Development/Grants, delivered a presentation on the Appalachian Regional Commission (ARC) Local Access Road Program. She invited MPO members to submit candidate projects for consideration and shared examples of current projects that have received ARC funding. Ms. Lockwood emphasized that the program is focused on economic development and reviewed the program's eligibility criteria and application requirements.

Ms. Lockwood also noted that SEDA-COG can assist with developing and preparing funding applications. She said that beginning on Jul. 1, SEDA-COG staff will start charging fees for grant-writing assistance. Previously, this service was supported by federal funding. The fees collected will be used to cover SEDA-COG's costs associated with developing and preparing grant applications.

### **Draft 2027-2030 Transportation Improvement Program**

Mr. Herman highlighted updates to the project list and at-a-glance summary charts since the Jan. 30 meeting. As a result of project additions and adjustments, overall funding has increased to more than \$500 million, and the draft Transportation Improvement Program (TIP) now includes a total of 269 projects.

Ms. McLaughlin stated that the public comment period for the Draft 2027–2030 TIP will run from Apr. 22 through May 22. She noted that a public meeting will be held at the Union County Government Center on the morning of May 4. Ms. McLaughlin recommended approval, if acceptable, to advertise the Draft 2027–2030 SEDA-COG TIP for public comment.

***Mr. Lettiere made a motion to advertise the Draft 2027-2030 SEDA-COG Transportation Improvement Program for public comment. Mr. Molter seconded the motion; motion carried.***

### **Draft 2026-2050 Long-Range Transportation Plan**

Mr. Funkhouser provided a presentation reviewing the status of the 2050 SEDA-COG Long-Range Transportation Plan (LRTP). He noted that the plan is available to the public in both StoryMap and PDF formats. Mr. Funkhouser stated that the public comment period for the Draft 2026–2050 LRTP will run from Apr. 22 through May 22. He also reported that a public meeting will be held at the Union County Government Center on the morning of May 4, and that plan adoption is scheduled for the MPO meeting on Jun. 12, 2026.

Ms. McLaughlin stated that the meeting on May 4 will be a hybrid meeting with remote access availability.

Mr. Herman stated that outstanding items for the illustrative projects and a few other pieces will be added to the report before it goes out for public comment. A summation of public comments will be included in the final report.

Ms. McLaughlin recommended approval, if acceptable, to advertise the Draft LRTP for public comment.

***Mr. Lettiere made a motion to advertise the Draft 2026-2050 SEDA-COG Long-Range Transportation Plan for public comment. Mr. McLaughlin seconded the motion; motion carried.***

### **Active Transportation Committee Update**

Mr. Herman expressed appreciation to the individuals who assisted with and attended the Active Transportation Planning Workshop held on Mar. 20, 2026, at the Central Susquehanna Intermediate Unit (CSIU) in Montandon. He noted that a wide range of informational topics was covered during the workshop, which has led to additional municipal meetings to further discuss and advance potential projects.

Mr. Herman stated that the MPO’s regional bicycle and pedestrian plan from 2019 is being considered for updating. He explained that scoping efforts have begun to update the plan over the

next 12 to 15 months, with the goal of expanding them to cover the entire eight-county region. Mr. Herman noted that the updated effort would result in a comprehensive Active Transportation Plan designed to better align municipalities and partner organizations for successful project development and implementation.

### **Member Forum**

Mr. Herman said the Bridges and Safety Infrastructure for Community Success (BASICS) Act continues to be discussed in Congress and within committee hearings as part of the next federal transportation bill reauthorization. He noted that the current federal transportation authorization is set to expire on Sep. 30, 2026, and that updated information will be shared as it becomes available.

Mr. Herman said the Safe Streets and Roads for All program is open for applications until May 26.

Mr. Herman said the State College Area Connector Project's comment period is open through Apr. 20. More information can be found on the project page at PennDOT's website.

Emily Kelkis highlighted rabbittransit's Transit Asset Management (TAM) Performance Targets for fiscal year 2026. The Executive Summary was included in the meeting packet. The full TAM plan can be found on rabbittransit's website.

Mr. Herman said accessibility upgrades to Amtrak's Lewistown station began this week. This station is considered to be the oldest depot in the nation served by Amtrak. The press release regarding the renovations was included in the meeting packet.

PennDOT Plan for National Electric Vehicle Infrastructure (NEVI) Formula Program

*As part of the Bipartisan Infrastructure Law, PennDOT will receive and distribute \$171.5 million in formula funds for EV charging infrastructure. PennDOT was required to outline and submit a state EV infrastructure deployment plan to the U.S. Department of Transportation. PennDOT has also prepared an [EV Mobility Plan](#) that identifies specific actions to facilitate the transition to electrified mobility across Pennsylvania. PennDOT updated its annual [NEVI Plan](#) that was submitted on 8/27/25 and will support the allocation of FFY 2026 NEVI funds since it was [approved](#) on 9/5/25. Staff have been coordinating with PennDOT on the NEVI Community Charging Program. Staff submitted a list of proposed use cases and specific locations to PennDOT on 7/22/25 for consideration of funding for establishment of Community Charging stations and worked with PennDOT to refine potential locations of community charging stations for future contracting. PennDOT is moving forward with the community phase of the NEVI program, with approximately \$2 million targeted for investment in the SEDA-COG MPO region. The funding for the Central Region (which includes all SEDA-COG MPO counties) is expected to be opened in July or August of 2026. The proposal deadline for the Central Region will likely be March or April of 2027 with awards made in June or July of 2027. Mr. Kiel will be attending the Pittsburgh Area Clean Cities (PRCC) annual meeting on June 18<sup>th</sup> to learn what role PRCC may have in supporting our Community Charging stations development. PennDOT Carbon Reduction Strategy

*The federal Carbon Reduction Program (CRP) requires that each state develop a Carbon Reduction Strategy (CRS). PennDOT's final CRS was certified by FHWA in February 2024 and can be found [here](#); it will guide implementing the CRP in Pennsylvania. The SEDA-COG MPO is estimated to receive \$6.4 million in CRP funds through FFY 2026. CRP funds may only be used for projects that support the reduction of transportation emissions. PennDOT has developed a [Carbon Reduction Eligibility Examples](#) resource to aid in defining project eligibility.*

#### Planning Process – Project Development:

Infrastructure Investment and Jobs Act – also known as Bipartisan Infrastructure Law (BIL)

*On Nov. 15, 2021, H.R. 3684, the [Infrastructure Investment and Jobs Act](#), which reauthorizes surface transportation programs through Fiscal Year 2026, was signed into law. **FY 2026-27 PennDOT Multimodal Transportation Fund Round  
SEDA-COG MPO Region Application Comments**

**City of Lock Haven – Active Arts Corridor (City of Lock Haven, Clinton County)**

We concur with PennDOT District 2-0 comments. This project is of high importance to the City of Lock Haven. The proposed 1.75 mile Active Arts Corridor would be a shared-road area connecting the Bald Eagle Valley Trail into downtown Lock Haven, Robb Elementary School and Commonwealth University – Lock Haven. The project includes paving, curb transitions, signage and road markings. It would provide a safer way to navigate the City for bicyclists, pedestrian, as well as those using e-bikes and scooters. Preliminary design has been completed. The City is commended for committing over 42% match towards the project. This project supports Lock Haven’s Active Transportation Plan and is consistent with the projects and implementation strategies included in the SEDA-COG MPO Long-Range Transportation Plan (LRTP).

**Clinton County – SR 150 Pedestrian Safety Improvement Project (Flemington Borough, Clinton County)**

We concur with PennDOT District 2-0 comments. This project is of high importance to Clinton County. This project received funding from PennDOT’s Transportation Alternatives Set-Aside Program that will cover the construction costs of this project. Because PennDOT Multimodal funds can be used towards right-of-way and design, if awarded, the PennDOT Multimodal funds cover the ROW and design phases. TASA funding would be used for construction.

**Lamar Township – PennDOT Multimodal 2026 - Paving Project (Lamar Township, Clinton County)**

We concur with PennDOT District 2-0 comments. This project is of high importance to Lamar Township. The project would reconstruct and widen eight miles of roadway in the Township, as well as improve drainage on Beagle Road, East End Mountain Road, Eisenhower Crossroad, Burrell Road, and Stovers Crossroad. The project would improve safety for Plain Sect/Amish communities in the area. The project does not have a design. The Township is commended for committing 43% match towards the project. This project is consistent with the projects and implementation strategies included in the SEDA-COG MPO Long-Range Transportation Plan (LRTP).

**Lamar Township – Paving Project - Phase 2 (Lamar Township, Clinton County)**

We concur with PennDOT District 2-0 comments. This project is of high importance to Lamar Township. The project would mill and pave 2.44 miles of roadway within the Township, including Airstrip Drive, Ridge Road, Dunkle Road, Heckman Gap Road, and Mill Street, and add shoulder back up for drop-offs, which would allow for a more solid base and less wear from particularly Amish farm equipment and buggies. The project would improve safety for Plain Sect/Amish communities in the area. The project does not have a design. The Township is commended for committing 43% match towards the project. This project is consistent with the projects and implementation strategies included in the SEDA-COG MPO Long-Range Transportation Plan (LRTP).

### **Fermanagh Township - Big Run Rd Bridge Repair (Fermanagh Township, Juniata County)**

We concur with PennDOT District 2-0 comments. This project is of high importance to Fermanagh Township. The project consists of replacing a structurally deficient bridge with an Aluminum Structural Plate Box Culvert along Big Run Road. A recent bridge inspection indicated that the structural problems should be addressed within one year. The new structure would address the safety issues of the bridge, permit truck traffic, and allow for development opportunities. The project has not yet been designed. The Township is commended for committing 41% match towards the project. This project is consistent with the projects and implementation strategies included in the SEDA-COG MPO Long-Range Transportation Plan (LRTP).

### **Menno Township - SR 655 Allensville Traffic Calming/Streetscape Project Phase 1 (Menno Township, Mifflin County)**

We concur with PennDOT District 2-0 comments. This project is of high importance to Menno Township and was identified as a priority project in Mifflin County's Active Transportation Plan, MifflinMoves. The small community of Allensville in Menno Township has significant through traffic, including trucks, and speeding is a great concern for the community. This project would include traffic calming and streetscape upgrades along SR 655, including high-visibility crosswalks, and two gateway medians at each approach to the community. These treatments will reduce speed, improve safety for all users, and support local economic growth. The project has not yet commenced design. The Township is commended for its collaborative approach to enhancing safety and slowing traffic, and for committing 42% match towards the project. This project is consistent with the projects and implementation strategies included in the SEDA-COG MPO Long-Range Transportation Plan (LRTP).

### **Wayne Township – Ferguson Valley Road Project (Wayne Township, Mifflin County)**

We concur with PennDOT District 2-0 comments. This project is of high importance to Wayne Township. The project consists of over a mile of roadway and base repairs, and associated improvements that are greatly needed. The project site incorporates several modes of transportation including regular vehicle traffic, Amish horse and buggy, bicycles, pedestrians, and recreational equestrian traffic. This is the last phase of the project and final design has been completed. The Township is commended for committing significant match towards the project. This project is consistent with the projects and implementation strategies included in the SEDA-COG MPO Long-Range Transportation Plan (LRTP).

### **Berwick Borough – Pathways to Progress Phase 2 (Berwick Borough, Columbia County)**

We concur with PennDOT District 3-0 comments. This project is of high importance to Berwick Borough. This project will reconstruct approximately 1 mile of Susquehanna Avenue to address deteriorating conditions and improve ADA access. Implementation of the improvements will provide pedestrian connectivity to businesses, schools, parks, as well employers such as Wise Foods. The corridor connects to the Blueprint-designated Uptown business district and supports the Blueprint Revitalization Plan. In addition, it leverages the momentum of the implementation of Phase 1 of the project. The project has not yet commenced design. This project is consistent with

the projects and implementation strategies included in the SEDA-COG MPO Long-Range Transportation Plan (LRTP).

**Town of Bloomsburg – 7th Street Community Safety & Access Initiative (Town of Bloomsburg, Columbia County)**

We concur with PennDOT District 3-0 comments. This project is of high importance to the Town of Bloomsburg and provides improvements to East 7th Street between Old Berwick Road and Locust Street. Increased truck traffic in this area has accelerated road deterioration. The project would address existing pavement and drainage deficiencies along the street, signage and pavement markings, as well as establish continuous ADA-compliant sidewalks and curbing. This project was identified in the Walk Bike Bloomsburg Connectivity Master Plan. Design has not yet commenced for the project. The Town is commended for committing 45% in local match towards the project. This project is consistent with the projects and implementation strategies included in the SEDA-COG MPO Long-Range Transportation Plan (LRTP).

**East Buffalo Township– West Market Street Safety Improvement Phase 2 (East Buffalo Township, Union County)**

We concur with PennDOT District 3-0 comments. This project is of high importance to East Buffalo Township in Union County and would provide new pedestrian facilities along West Market Street where none currently exist. The improvements would include sidewalks, lighting, and landscaping along the south side of West Market Street between Route 15 and 16<sup>th</sup> Street, thereby improving pedestrian safety and connectivity to the Linntown neighborhood, downtown Lewisburg, and the Buffalo Valley Rail Trail. Final design is complete. This project recently received funding for two of the four phases of the project, including Congressionally Directed Spending and Transportation Alternative Set-Aside Program funds. This multimodal application would provide the Township with the opportunity to work in conjunction with the other funding sources and thus make the overall construction more efficient with the least disruption in this heavily travelled area. The applicant is commended for committing more than 40% in local match towards the project. This project is consistent with the projects and implementation strategies included in the SEDA-COG MPO Long-Range Transportation Plan (LRTP).

**Asbury Foundation – Riverwoods Downtown Lewisburg Connector Initiative (Kelly Township, Union County)**

We concur with PennDOT District 3-0 comments. This project is of high importance to many stakeholders, including the Absury Foundation, Riverwoods Senior Living Community, and the Borough of Lewisburg. This project will construct new ADA compliant sidewalks and pedestrian improvements connecting RiverWoods senior living community to the Lewisburg area at the St. Anthony Street Bridge, providing separation for pedestrians, particularly seniors and individuals with mobility limitations. This will also provide pedestrian connections to AYSO soccer fields and the Susquehanna River. Design for the project has not yet commenced. The Foundation is commended for committing more than 42% match towards the project. This project is consistent with the projects and implementation strategies included in the SEDA-COG MPO Long-Range Transportation Plan (LRTP).

**Kelly Township – Hospital Drive Roundabout and Pedestrian Connectivity (Kelly Township, Union County)**

We concur with PennDOT District 3-0 comments. This project is of high importance to Kelly Township in Union County. This project would install a new roundabout along with associated intersection widening and approach realignment to optimize traffic flow. Located in an area with several medical care facilities, retail stores and restaurants, as well as childcare and school facilities, the project would include enhanced signing, pavement markings, utility relocation, and pavement markings. The design will permit pedestrian improvements such as sidewalks in the future. Roundabouts are effective techniques to improve traffic flows through intersections, reduce intersection delays, and reduce fatal and injury crashes. The SEDA-COG MPO is interested in seeing more of these proven safety countermeasures implemented in this region. Final design was completed in April 2025. The Township is commended for developing an innovative solution for this intersection and improving connectivity for motorists and pedestrians/bicyclists. This project is consistent with the projects and implementation strategies included in the SEDA-COG MPO Long-Range Transportation Plan (LRTP). Kelly Township received a previous award of PennDOT Multimodal funds for this project; however, it was not in an amount sufficient to advance the project to construction. An award of the requested amount would close the funding gap.

The SEDA-COG MPO carried out a 30-day public review and comment period on the 2050 LRTP. The public comments were addressed and are incorporated as an appendix in the final 2050 LRTP document.

The SEDA-COG MPO Board, representing the MPO by a majority vote, hereby adopts the 2050 Long-Range Transportation Plan for the SEDA-COG MPO region.

**RESOLUTION 2026-2**

**RESOLUTION** of the SEDA-COG Metropolitan Planning Organization (MPO) to certify that the metropolitan transportation planning process is being carried out in accordance with all applicable federal requirements and that the local process to enhance the participation of the general public, including the transportation disadvantaged, has been followed in developing the Transportation Improvement Program (TIP) and the Long-Range Transportation Plan (LRTP).

**WHEREAS**, 23 CFR Part 450.336 specifies that, concurrent with submittal of the proposed TIP to the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) as part of the Statewide TIP (STIP) approval, Metropolitan Planning Organizations (MPOs) shall certify that the metropolitan transportation planning process is being carried out in accordance with all applicable requirements; and

**WHEREAS**, Sections 134 and 135 of Title 23 USC, 49 USC 5303-5304, and 23 CFR Part 450 set forth the national policy that the MPO designated for each urbanized area is to carry out a continuing, cooperative, and comprehensive multimodal transportation planning process, including the development of a TIP and LRTP, and establish policies and procedures for MPOs to conduct the metropolitan planning process; and

**WHEREAS**, the TIP continues to be financially constrained as required by 23 CFR Part 450.326 and the FTA policy on the documentation of financial capacity, published in FTA Circular 7008.1A; and

**WHEREAS**, the requirements of Sections 174 and 176(c) and (d) of the Clean Air Act, as amended (42 USC 7504, 7506(c) and (d)) and 40 CFR Part 93 have been met for non-attainment and maintenance areas; and

**WHEREAS**, the requirements of Title VI of the Civil Rights Act of 1964 as amended (42 USC 2000d-1) and 49 CFR Part 21; 49 USC 5332, prohibiting discrimination on the basis of race, color, creed, national origin, sex or age in employment or business opportunity; The Older Americans Act, as amended (42 USC 6101), prohibiting discrimination on the basis of age in programs or activities receiving federal financial assistance; 23 USC Section 324, prohibiting discrimination based on gender; Section 504 of the Rehabilitation Act of 1973 (29 USC 794), the Americans with Disabilities Act of 1990 (42 USC 12101 et seq.), and 49 CFR Parts 27, 37, and 38, regarding discrimination against individuals with disabilities have been met; and

**WHEREAS**, Certification Documentation All requirements for EEO contract provisions and compliance involving Federal Aid Highway construction are addressed by PennDOT Districts and Central Office personnel. Per the U.S. DOT October 3, 2025, Interim Final Rule, DBE participation cannot be counted, and new DBE contract goals cannot be set until the Unified

Certification Program (UCP) completes the required reevaluation under 49 CFR § 26.111. Contracts executed before October 3, 2025, may not be modified.; and

**WHEREAS**, the provisions of 23 CFR Part 230, regarding the implementation of an equal employment opportunity program on federal and federal-aid highway construction contracts have been addressed; and

**WHEREAS**, the provision of 49 CFR Part 20 prohibiting recipients of federal funds from using those funds for lobbying purposes has been met; and

**WHEREAS**, 23 USC 150, 23 CFR Part 450, and 49 CFR Part 613 require MPOs to establish and use a performance-based approach to transportation decision making, SEDA-COG MPO continues to work with its partners to plan for the integration of performance measures and targets into the development of the TIP, Long-Range Plan, and other appropriate regional planning documents in accordance with federal and state statutes and guidance; and

**NOW, THEREFORE, BE IT RESOLVED** that the SEDA-COG MPO certifies that its metropolitan transportation planning process is being carried out in accordance with all applicable provisions of federal law and certifies that the local process to enhance the participation of the general public, including the transportation disadvantaged, has been followed in developing the region's transportation plans and programs, including the FFY 2027-2030 TIP and SEDA-COG MPO LRTP (see Exhibit 1).

## **Exhibit 1**

### **SEDA-COG MPO Self-Certification Documentation**

#### **Title VI**

It is the policy of the SEDA-COG MPO to assure full compliance with Title VI of the Civil Rights Act of 1964. The SEDA-COG MPO adopted its most recent Title VI Program and component Public Participation Plan (PPP) on June 10, 2022. The PPP identifies public participation principles, outreach techniques, and procedures to use when communicating with underserved populations (e.g., low income, minority, or elderly; persons with disabilities; and persons with limited English proficiency) for various SEDA-COG MPO activities. The PPP includes demographic information to identify underserved populations and specifies outreach techniques to involve the public and enhance participation in SEDA-COG MPO programs and activities.

The PPP is evaluated regularly. Achievements since the 2022 PPP was adopted include: expanding a database of interested parties; developing ADA notices/complaint procedures and designating an ADA Coordinator; updating MPO demographics to include more current American Community Survey datasets; completing community demographic assessments; making use of SurveyMonkey, MetroQuest, and Microsoft Forms for online public surveys; extending the reach of MPO notifications through social media; issuing quarterly SEDA-COG MPO e-newsletters; deploying more virtual public meetings; establishing a Public Participation Panel; publishing new interactive online maps; and leveraging the Social Pinpoint online community engagement tool.

Specific outreach activities for the development of the 2027-2030 SEDA-COG Transportation Improvement Program (TIP) are described in the Public Comment Period Summary for the TIP. This document is included in the package of information submitted to PennDOT following the MPO's adoption of the 2027-2030 TIP.

#### **Disadvantaged Business Enterprises (DBE) Requirements**

The administration of the SEDA-COG MPO's Unified Planning Work Program (UPWP) occurs through a legal agreement and periodic work orders executed by PennDOT and SEDA-COG. Staff services to the MPO are provided by employees of SEDA-Council of Governments through this agreement.

Contracts are sometimes awarded to outside vendors for planning studies on behalf of the SEDA-COG MPO via its UPWP. SEDA-COG awarded two (2) contracts to outside vendors in 2020 for maintenance, update and support of various required plans for the region. These consultant service contracts are expected to cover a period through June 30, 2027. One consultant agreement for planning services was executed with Michael Baker International, Inc. The

Michael Baker consultant team included a certified DBE firm. A second consultant agreement for planning services was executed with Gannett Fleming, Inc. The Gannett Fleming consultant team included a certified DBE firm. Per the U.S. Department of Transportation's October 3, 2025, Interim Final Rule, DBE participation cannot be counted, and new DBE contract goals cannot be set until the Unified Certification Program (UCP) completes the required reevaluation under 49 CFR § 26.111. Contracts executed before October 3, 2025, may not be modified.

### **Americans with Disabilities Act (ADA) Requirements**

The offices of the agencies that provide staff services or assistance to the SEDA-COG MPO are all ADA-compliant. All committee, subcommittee, and additional public meetings are held in ADA-compliant buildings. When possible, meetings are held in locations convenient for alternative transportation modes. All meeting advertisements include a request that special needs users contact SEDA-COG staff if special accommodations or arrangements need to be made. An example of a newspaper advertisement is included as Attachment A. ### **Transportation Improvement Program (TIP) Financial Constraint and Capacity Requirements**

The SEDA-COG MPO's 2025-2028 TIP was adopted in June 2024 and modified several times since the original adoption. The MPO and PennDOT utilize approved Procedures for TIP Revisions, which specify the revisions that must be formally approved by the SEDA-COG MPO, along with revisions that can be completed by administrative modifications. For each amendment that required formal action by the MPO, and for administrative modifications made by the project sponsors, a fiscal constraint chart was prepared illustrating the transfer of funds and verifying that annual funding was financially constrained. An example of a fiscal constraint chart for a TIP amendment is included as Attachment B. Similar processes and procedures were approved and will be utilized to administer the 2027-2030 TIP.

Pursuing Federal Grant Funding: A Guide for Regional and Local Applicants

***PennDOT updated this [Guide](#) in November 2025. PennDOT first issued it as a Guide for Developing IJIA Grant Proposals in 2022 to aid in developing high-quality grant proposals to compete for the discretionary funds made available through the Infrastructure Investment and Jobs Act (IIJA). Rebranding the guide broadens the focus beyond individual transportation funding laws. The principles within apply broadly to most federal grants. The guide is periodically updated to capture best practices and lessons learned.***

Bridge Investment Program

***The Bridge Investment Program is a discretionary program that focuses on existing bridges to reduce the overall number of bridges in poor condition, or in fair condition at risk of falling into poor condition. ## **PennDOT District 2 Construction Overview – Shapiro Administration to Invest \$212 Million in 80 Projects to Improve Roads and Bridges in 2026**

5/20/2026

**Clearfield, PA** – Pennsylvania Department of Transportation (PennDOT) Secretary Mike Carroll announced today that the department is investing \$212 million in 80 projects in its Clearfield-based region this year to improve Pennsylvania’s roads and bridges so that drivers can get to their destinations safely and on time. This investment in state and local roads and bridges supports **Governor Josh Shapiro’s** vision of a safe and reliable transportation network that connects people to opportunity and each other.

“Investment in Pennsylvania’s roads is an investment in Pennsylvania’s future,” said **Secretary Carroll**. “Roads support millions of jobs in the retail, tourism, and construction industries, which makes maintaining and expanding our network essential to Pennsylvania’s long-term success. Governor Shapiro recognizes this and continues to show his commitment to Pennsylvania’s future with this more than \$200 million investment.”

Under **Governor Shapiro’s Administration**, **19,451 miles** of roads have been improved statewide, and work has advanced on **1,738 state and local bridges**. PennDOT is building on that momentum this year and anticipates investing \$212 million in District 2, which includes Cameron, Centre, Clearfield, Clinton, Elk, Juniata, McKean, Mifflin, and Potter counties. This investment includes reconstructing and resurfacing more than **115 miles of highways, sealcoating 316 miles of road, and repairing or replacing 77 bridges**.

“Our region has a diverse portfolio of new projects expected to start in 2026 in addition to the 16 projects carrying over from previous construction seasons,” said **PennDOT District 2 Executive Thomas Prestash**. “They include the construction of new highway infrastructure, preservation of existing highway and bridge assets across our nine counties, and highway safety improvement projects, all of which are focused on delivering a safe and reliable transportation network to Pennsylvania motorists.”

Work on a pair of Interstate improvement projects continues during the 2026 construction season. In Centre County, work on the high-speed interchange project connecting Interstates 80 (I-80) and 99 (I-99) in Centre County will enhance traffic safety by relieving traffic congestion along Route 26, providing a direct connection between the two interstates and making it unnecessary to travel Route 26 to access them.

In Juniata and Mifflin counties, a project to improve the ride quality and extend the service life of more than 16 miles of road between Arch Rock and Mifflintown resumed early in March and is expected to wrap around Labor Day.

Notable projects that are expected to begin or continue this year by county include:

### **Clinton County**

- Route 220 bridge preservation project impacting six structures in Castanea Township, \$1.2 million.

- Route 120 highway restoration and slide repair near West Port in Noyes Township, \$1.9 million.

#### **Juniata County**

- Route 235 bridge replacement project over Stoney Run in Greenwood Township, \$1.3 million.

#### **Mifflin County**

- Route 22 highway restoration project between Arch Rock and Mifflintown, \$5.7 million.
- Route 522 highway resurfacing project from Lewistown to the Snyder County line, \$4.9 million.

As construction projects are underway in the region, the traveling public can anticipate seeing many work zones in addition to those listed above and are urged to keep in mind their safety and the safety of highway workers. When encountering a work zone, please drive the posted speed limit, turn on your headlights, pay close attention to signs and flaggers, and avoid all distractions.

## Fatal Crashes and Traffic Deaths Decline in 2025 to Lowest Level on Record

**Harrisburg, PA** – The **Pennsylvania Department of Transportation (PennDOT)** announced today that the number of people killed in traffic crashes reached a new low in 2025, dropping to 1,047, the lowest since record keeping began in 1928 and 80 less than 2024.

“Even one life lost is one too many, so while this decrease is good news, Pennsylvania remains committed to moving toward zero deaths on our roadways,” said **PennDOT Secretary Mike Carroll**. “PennDOT will continue to do our part to decrease fatalities through education and outreach, but we will only reach zero when we all work together. Please drive safely. Put the phone down when you are behind the wheel. Always follow the speed limit and never drive impaired. And buckle up! Your seat belt can save your life in a crash.”

In 2025, there were 109,515 total reportable crashes, the second lowest on record only to 2020, when traffic volumes were down statewide due to the COVID-19 pandemic. Of the total traffic crashes, there were 979 fatal crashes, the lowest on record and down from 1,060 in 2024.

Under the Shapiro Administration, PennDOT invested more than \$70 million statewide in federal grant funds in [behavioral safety programs](#) to reduce fatalities and serious injuries, as part of **Governor Josh Shapiro’s** mission to provide a safe transportation system for all Pennsylvanians.

In addition to behavioral safety, PennDOT focuses on [infrastructure improvements](#) to improve safety. More than \$357 million in federal Highway Safety Improvement Program funds were invested in 312 unique safety projects from 2023 to 2025. During that same time, another \$30 million in state funds was invested in low-cost safety improvements at hundreds of locations – which include centerline and edge-line rumble strips, warning signs and pavement markings, and high friction surface treatments. PennDOT currently has \$106.5 million in HSIP funds committed to 198 unique safety projects in 2026.

The number of fatalities in impaired driver crashes dropped from 342 in 2024 to 258 last year, the lowest number on record. PennDOT annually distributes more than \$6.7 million from the National Highway Traffic Safety Administration (NHTSA) for impaired driving enforcement. Impaired driving mobilizations include [high-visibility enforcement and education campaigns](#) that aim to eliminate driving under the influence.

Fatalities in lane departure crashes (crashes where a vehicle left its travel lane) dropped from 537 in 2024 to 492 last year, the lowest on record. [PennDOT’s Low-Cost Safety Improvement Program](#) has implemented proven safety countermeasures at thousands of locations over the last 15 years. These include rumble strips, high friction surface treatments, high-tension cable median barriers, and curve warnings in advance through signs and pavement markings.

Fatalities where a driver or passenger wasn’t wearing a seat belt dropped from 311 in 2024 to 259 last year, the lowest number since record keeping began. These fatalities are completely preventable, and data shows that seat belts save lives. It is estimated that 90% of unbelted occupants, or 233 people, who were killed in crashes while traveling in passenger vehicles could have survived if they had been buckled up. [PennDOT urges drivers and passengers to do their part to help reduce unrestrained fatalities to zero - buckle up every trip, every time.](#)

While fatalities for most types of crashes were down in 2025, some types saw increases. Fatalities involving aggressive driving have gone up 31% since 2020, the year of the record low. Aggressive driving includes running a stop sign or red light, tailgating, sudden slowing or stopping, careless passing or passing in a no passing zone, speeding or driving too fast for conditions, and more. PennDOT invests approximately \$18.4 million annually in federal grant funds statewide, partnering with state and local police to deliver [high-visibility enforcement](#), including three enforcement waves focused on aggressive driving, with the [most recent wave announced March 18](#).

Bicyclist fatalities increased from 19 in 2024 to 28 last year. Of the 28 bicyclist fatalities, 14 were not wearing a helmet. In Pennsylvania, children under the age of 12 must wear a helmet while riding a bicycle, but PennDOT strongly recommends that all bicyclists wear helmets whenever they ride. Twelve bicyclists were riding an e-bike. E-bikes have an electric assist and travel at higher speeds. While fatalities involving a distracted driver were up slightly, from 49 in 2024 to 54 last year, the long-term trend is decreasing, thanks in part to Pennsylvania's new hands-free law. [Signed into law in June 2024](#) and [effective in June 2025](#), Paul Miller's Law prohibits the use of hand-held devices while driving, even while stopped temporarily due to traffic, a red light, or other delays. Drivers can still use their phones to alert authorities in the event of an emergency and use hands-free technology to make phone calls, use a GPS, and listen to music. Beginning June 5, 2026, drivers convicted of using a hand-held device while driving will pay a \$50 fine, plus court costs and other fees.

Distracted driving crash data is believed to be underreported due to many drivers' reluctance to admit to being distracted at the time of a crash. Cell phone use is not the only distraction while driving. Anything that takes your attention away from driving, your eyes off the road, or your hands off the wheel is a distraction. If distraction results in unsafe driving, drivers can be stopped by police for [careless driving](#).

Fatalities in crashes involving a driver aged 65 to 74 years old increased from 162 in 2024 to 185 in 2025. The number of licensed Pennsylvania drivers in this age group has increased 24% over the last 10 years, while overall PA licensed driver growth is approximately two percent. Older drivers aren't necessarily unsafe drivers, but the decision to stop should be made by an older driver, their doctor, and their family. Fatalities in crashes involving a teen driver aged 16 to 17 years old increased from 27 in 2024 to 31 last year. PA law requires learner's permit holders to have 65 hours of behind-the-wheel skill building before taking the driver's skills test. Of the 65 hours, 10 hours must be at night, and five hours must be during bad weather. Parents and guardians should set a good example by practicing safe driving on every trip, especially when kids or teens are in the vehicle. Drivers' behavior is the leading factor in 83 percent of the fatal crashes that occur annually on Pennsylvania roadways. These behaviors include driving distracted, impaired, aggressive, and others. These behaviors are choices. Drivers don't intend to cause a crash, but their choices kill innocent people every day. Choose to do the right thing because your choices are no accident.
