## Call to Order

After it was determined that a quorum was present, Mr. Herman called the meeting to order at 9:30 a.m.

#### Public Forum

Mr. Colussy stated that he is stepping down as the Planning Director for Mifflin County. Lonnie Griffith, Maintenance Director, will be the interim county contact for MPO matters until the planning director position has been filled.

#### Approval of the January 20, 2023, Meeting Minutes of the SEDA-COG MPO

*Mr. Kerstetter made a motion to approve the minutes from the January 20, 2023, MPO meeting; Mr. Molter seconded the motion; motion carried.*

Mr. Schultz summarized the TIP amendments for PennDOT District 2-0.

#### CSVT Project and SR 54 Safety Project Status Reports

#### CSVT Northern Section

Mr. Ranck stated that eight overhead sign structures will be installed this spring in Montandon and Winfield. Work is anticipated to be completed in June. Traffic is using the Northern Section effectively.

#### Financial Plan Annual Update

Mr. Ranck stated that PennDOT recently finalized the 2022 Financial Plan Annual Update (FPAU) for submission to FHWA. The total estimated project cost has increased from \$903 million to \$938 million. The \$35 million increase is almost exclusively the result of inflation.

#### CSVT Southern Section

Mr. Ranck stated that construction of the first contract to complete most of the earthwork began in May 2022 and is expected to be completed in March 2025. The project is 17% completed based on cost and 29% based on time. Less than 10% of the earthwork is complete. Work to date includes clearing and grubbing, excavation, construction of embankments, construction of drainage facilities including cast-in-place box culverts and large pipes, construction of erosion and sedimentation facilities, realignment of local roadways and relocation of various utilities. A new structure on Sunbury Rd will be constructed over the CSVT mainline in 2023. Mass excavation for this project is scheduled to begin soon.

Mr. Ranck stated that plans are being completed for nine new bridges that will be included in the Southern Section Structures Contract. Preparation has begun on the specifications and other bidding documents for this project. PennDOT anticipates letting that contract later in 2023 and starting construction work on the structures in 2024.

Mr. Ranck stated that plans for the Southern Section Paving Contract are advancing. The focus will be on refining the access modifications needed for properties adjacent to CSVT's southern interchange with existing Routes 11/15 and 522, in order to accommodate safe traffic movements on all four quadrants of that interchange. PennDOT is coordinating with affected property owners for the partial right-of-way acquisitions required to accommodate those access modifications.

#### SR 54 Section 090 Intersection Realignment with SR 642 in Montour County

Mr. Ranck provided the following updates for this project:

- The preliminary right-of-way plan has been approved and the final right-of-way plan is anticipated to be submitted in early April 2023
- The waterway permit has been approved for stream crossings
- The NPDES permit has been submitted and is currently in technical review with PA DEP
- The E&S Plan has been approved by Montour County Conservation District
- Some modifications to the stormwater management design were needed which impacted the right-of-way plan
- PennDOT is in the process of organizing an update meeting with the Community Advisory Committee to be held in early summer 2023
- The project is currently scheduled to be let in spring 2024
- Due to the funding and innovative intersection design (displaced left turn), approval from the FHWA is required in final design and is anticipated in fall 2023

Mr. Buck provided an update on the Active Transportation Committee. The next Committee meeting will be held on May 17, 2023. Committee Work Group meetings will be determined in the future. An Esri Hub site will be developed to host data, charts, and maps related to the Middle Susquehanna Regional Bike/Ped Plan.
