Call to Order

After it was determined that a quorum was present, Mr. Saylor called the meeting to order at 9:31 a.m.

Public Forum

No comments were received from the general public.

PennDOT Pathways Initiative Presentation

Mr. Larry Shifflet, PennDOT Deputy Secretary for Planning, provided a PennDOT Pathways Initiative presentation

PennDOT Pathways is a program to help find a path to secure reliable future-focused funding solutions for the transportation system. PennDOT Pathways will allow PennDOT to re-imagine what transportation funding looks like in Pennsylvania to meet the growing needs and serve communities. An alternative funding Planning and Environmental Linkages (PEL) study was launched in November 2020 and is underway to identify near-and long-term funding options and establish a methodology for their evaluation. Viable solutions will be launched as PennDOT Pathways Initiatives over the coming years.

PennDOT's largest source of revenue – 74 percent – comes from state and federal gas taxes. PennDOT is dependent on gas taxes to fund the transportation program. These funds are generated every time a driver in Pennsylvania refills their car's gas tank.

The Major Bridge P3 Initiative will further explore the feasibility of bridge tolling in parallel with the PEL. The Major Bridge P3 Initiative is designed to raise revenue through tolling to address the state's growing backlog of replacement and rehabilitation needs for major bridges that are approaching the end of their useful lives.

Input has been sought from the public on the alternative funding options being evaluated for the PEL study. Approximately 6,000 people attended the online engagement opportunity and approximately 375 comments were received. The result of this outreach and the completed analysis of the potential alternative funding options will be documented within the PEL document, and the PEL study will be made available for public comment in the spring of 2021.

Approval of the January 22, 2021 Meeting Minutes of the SEDA-COG MPO

Mr. Molter made a motion to approve the minutes from the January 22, 2021, MPO meeting; Mr. McLaughlin seconded the motion; motion carried.

Mr. Kerstetter made a motion for the MPO to approve the TIP administrative actions as presented for PennDOT District 2-0; Mr. Colussy seconded the motion; motion carried.

Mr. Saylor summarized the administrative actions for PennDOT District 3-0.

Mr. Phillips made a motion for the MPO to approve the TIP administrative actions as presented for PennDOT District 3-0; Mr. McLaughlin seconded the motion; motion carried.

Central Susquehanna Valley Transportation (CSVT) Project Status

Mr. Ranck provided the following update:

CSVT Northern Section

- Nothing further to update from last meeting except that paving operations will be recommencing in the next few weeks. Still on track to open the Northern Section in 2022.

CSVT Southern Section

- Final Design Draft construction plan set is under review.
- Right-of-Way Plan has been finalized, coordination continuing. There are 75 right-of-way parcels that need acquired.
- Utility coordination continuing.
- Waterway and wetland permits are to be submitted to environmental agencies by the end of March.
- NPDES is to be submitted to DEP and Snyder County Conservation District by the end of April.
- Earthwork contract (first of three planned contracts) anticipated to be let in fall/winter of 2021.
- On track to start construction in 2022.
- Completion anticipated in 2027.

Ms. de Silva stated that the Bald Eagle Valley Trail river crossing project is under construction.

Mr. Ranck provided an update on the Bull Run Greenway Phase 1 project in Lewisburg Borough and stated that funds were obligated on March 12th, and the project was advertised on March 18th.

Mr. Schultz provided an update on the Brown Township Streetscape project in Mifflin County and stated that the contract was awarded, and that a notice to proceed is coming soon.

Mr. Herman stated that PennDOT is anticipating opening a new round of candidate projects for the TA Set Aside statewide solicitation in late June 2021. PennDOT is expecting \$18 million to be available statewide. Mr. Herman also summarized the following handouts in the packet.

Mr. Smoker complimented SEDA-COG, staff and those individuals on the committees for the hard work done in putting together the LRTP. He stated it was comprehensive, and a lot of data was included.

2023 Twelve Year Program Public Participation

Mr. Herman reviewed the following items provided in the meeting packet:

Mr. Herman stated that a public survey is open until April 14 and there is a March 23 online public forum related to the 2023 Twelve Year Program Update.

Local Bridge Prioritization Process for 2023 TIP

Ms. Wilde stated that all of the MPO counties have meetings scheduled over the next few weeks to discuss their bridge priorities. Staff will soon be starting the GIS analysis. As the next step, a survey will be sent in May or June for the 2023 TIP.

Active Transportation Committee Update

Ms. Wilde stated that a funding workshop was held on February 24 which went well. There was good representation from PennDOT and DCED, as well as Mr. Herman discussing grant programs and LTAP information. A representative from Traffic Planning and Design consultant firm also shared his input. The Committee finalized some adjustments on its policies and procedures document. The next meeting will be held on May 19th. The transportation department has an intern, Olivia Zavrel from Bucknell University, who is working on adding to the sidewalk inventory for the MPO region.

Member Forum

Mr. Saylor stated that it appears that Congress is opening the door to go back to an earmark system for the pending highway reauthorization bill. There are limits and conditions on this. It is limited to 1% of the discretionary funding and limited to 10 submissions per congressperson and requires a letter from a local sponsor.

Mr. Smoker commented that there is a lot of discussions in Washington at the present time on this. There is talk of an infrastructure bill, reauthorization proposals which could be separate from an infrastructure bill as well as a lot of guidance on policies coming from the new administration regarding some of their new priorities which include climate change, resiliency, equity, and

transportation. As information becomes available through the Federal Highway Administration, he will pass that along to PennDOT and the MPO's across the state.
