These notices shall satisfy two separate but related procedural requirements for activities to be undertaken by City of Williamsport.

REQUEST FOR RELEASE OF FUNDS

On or about October 21, 2025, the City of Williamsport will submit a request to the U.S. Department of Housing and Urban Development (HUD) for the release of Community Development Block Grant (CDBG) funds under Title I of the Housing and Community Development Act of 1974, Public Law 93-383, as amended, to undertake a project known as Willow Street Design. Anticipated activities associated with this project include The City of Williamsport has allocated Community Development Block Grant (CDBG) entitlement funds FFY 2021, B-21-MC-42-0017, in the amount of \$183,941.00 to the Willow Street Design project on Willow Street in the City of Williamsport, Lycoming County, Pennsylvania.

The proposed scope of work includes installation of 1,250 feet of mill of 1.5-inch depth, 15 feet in width, on Willow Street. The new asphalt will be overlayed with a 1/8-inch layer of polymer cement.

FINDING OF NO SIGNIFICANT IMPACT

The City of Williamsport has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. PUBLIC COMMENTS

Any individual, group, or agency may submit written comment on the Environmental Review Record to the Bill Scott comments received by October 20, 2025 will be considered by the City of Williamsport prior to authorizing submission of a Request for Release of Funds. Comments should specify which Notice they are addressing.

ENVIRONMENTAL CERTIFICATION

The City of Williamsport certifies to HUD that Bill Scott, in his capacity as City Engineer, consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the City of Williamsport to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to its release of fund and the City of Williamsport's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City of Williamsport; (b) the City of Williamsport has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR

part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to the Philadelphia Office of Community Planning and Development at CPDRROFPHI@hud.gov. Potential objectors should contact HUD to verify the actual last day of the objection period.
